The Nuclear Transparency Watch network and the European Commission (DG ENER), [in coordination with ENSREG, ANCCLI and the EEB] are organising an Aarhus Convention and Nuclear (ACN) Round Table on "*Implementation of the Nuclear Safety Directive: transparency, public participation, and the role of civil society in independent nuclear regulation*" with sessions to be held on January 21st and 22nd, 2025.

Based on the three pillars of the Aarhus Convention - access to information, public participation and access to justice in environmental matters, and in view of the fact that the Nuclear Safety Directive (NSD) lays down requirements on availability of nuclear safety-related information and public participation in the decision-making process relating to the licensing of nuclear installations, this Round Table will address the topics of transparency, public participation and the interaction between the nuclear regulatory system and civil society concerning nuclear safety. A strong and consistent implementation of the Aarhus Convention benefits the implementation of the Nuclear Safety Directive. The event will encourage an open exchange of views and experience between the participants, coming from a broad spectrum of stakeholders, with the aim to identify challenges, and best practices to address them.

First half-day: January 21st, 2025

Welcome, introduction to Nuclear Safety Directive and to this ACN roundtable

14:15 Implementation of the NSD with respect to the provisions on transparency and public participation, and the scope for the independent regulator and the licence holder to act as facilitators

This session will focus mainly on the views of different stakeholders on the implementation of NSD Article 8, in relation to Article 5.
